

THE SKYY VODKA BORN FOR THE SUMMER SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING.

The SKYY Vodka Born For The Summer Sweepstakes (“Sweepstakes”) is sponsored by Campari America (“Sponsor”), 1114 Avenue of the Americas, 19th Floor, New York, NY 10036 and is administered by Prize Logic, LLC, (“Administrator”), Two Towne Square, Suite 200, Southfield, MI 48076.

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on May 11, 2022 at 12:00 PM Eastern Time (“ET”) and ends on August 31, 2022 at 11:59:59 PM ET (“Sweepstakes Period”) and includes two (2) entry periods (each an “Entry Period”) as outlined in the chart below:

Non-winning entries will carry forward into the subsequent Entry Period drawing. The Administrator’s computer is the Sweepstakes official clock.

2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States (including the District of Columbia) who are at least twenty-one (21) years old at the time of entry. Employees of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, “Sweepstakes Entities”) and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the “steps” of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. Employees, agents and officers of alcohol beverage retailers and distributors and their immediate family members and all other individuals/entities associated with this Sweepstakes are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.

Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant’s residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.

3. **HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, an eligible entrant may visit SKYYBornForTheSummer.com (“Website”) and complete and submit the registration form including, but not limited to: his/her first and complete last name (no initials), valid e-mail address, phone number, street address (no P.O. Boxes will be allowed), city, state, and zip code. Entrant must follow the links and instructions to complete a profile quiz (“Quiz”). Upon the successful submission of the registration information and completion of the Quiz, an entrant will receive one (1) entry into the applicable Entry Period.

Entry Limit: There is a limit of one (1) entry per person per day. If more than one (1) entry per day is received from the same person, telephone number and/or e-mail address the entries may, at the Sponsor’s sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-

mail address or multiple identities. If it is found or suspected that an entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that entrant, in Sponsor's sole discretion, may not be eligible to win a prize. A "day" is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET on a calendar day during the Sweepstakes Period, except on May 11, 2022 when a day is defined as starting at 12:00 PM ET and ending at 11:59:59 PM ET.

NOTE: During the Sweepstakes Period, an entrant may receive a link to the Website by scanning the QR code on select Sweepstakes print advertising. An entrant may center the QR code in the camera and scan the QR code. Once completed, the entrant will receive a link to the Website, and may follow the steps noted above to enter the Sweepstakes. **An entrant cannot participate solely by scanning the QR code.**

IMPORTANT: MESSAGE AND DATA RATES MAY APPLY IF AN ENTRANT ENTERS THIS SWEEPSTAKES ON HIS/HER MOBILE DEVICE. RANDOM DRAWING: On or around each drawing date indicated in the chart above in Section 1, the Administrator will randomly select four (4) potential grand prize winners for Entry Period 1 and two (2) potential grand prize winners for Entry Period 2, five (5) potential first prize winners, and five (5) potential second prize winners from all eligible entries received for each Entry Period. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

i. Entry Period 1 Grand Prize To Music Midtown (2): Entry Period 1 Grand Prize is a trip to Atlanta, GA to attend Music Midtown at Piedmont Park in Atlanta, GA scheduled to take place on yet to be announced dates in September 2022 ("Entry Period 1 Music Midtown Grand Prize"). Each Entry Period 1 Grand Prize to Music Midtown includes round-trip coach class air transportation from a major commercial airport near winner's residence to Atlanta, GA for winner and one (1) adult guest, three (3) nights hotel standard accommodations (single room/double occupancy), two (2) 2-day general admission tickets to Music Midtown 2022, \$600 for winner only. Winner's guests must be twenty-one (21) years of age or older. Winner and guests must abide by all festival and venue policies. Festival Entities reserve the right to revoke full or partial prize from any winner or winner's guest who it and/or festival/venue personnel deem may, in their sole discretion, be intoxicated, be a safety risk, have violated any festival/venue policy or law, and/or may bring Sponsor or Festival Entities into disrepute. Sponsor and Festival Entities have no responsibility for lost, stolen, misplaced or mutilated tickets, or any other occurrences beyond their control. No refund or compensation will be made in the event of the cancellation or delay. Sponsor and Festival Entities have no

responsibility for a winner's inability or failure to accept or use any part of the prize as described herein. By claiming tickets, you agree to Front Gate Tickets' [Terms of Use](#), and to abide by the health and safety measures in effect at the time of your event, which may include, but not be limited to, wearing masks, providing proof of vaccination status and/or providing proof of negative COVID-19 status. Should the event be cancelled, you will be notified as soon as reasonably possible. Resale of passes/tickets is prohibited. If the winner elects to travel or partake in the Prize without a guest, no additional compensation will be awarded to the winner. Winner and guest must travel on dates determined by Sponsor in its sole discretion or prize will be forfeited. Winner and guests must travel on the same itinerary. The ARV of each Entry Period 1 Music Midtown Grand Prize is \$3,720.

- ii. **Entry Period 1 Grand Prize To Firefly Music Festival (2):** Entry Period 1 Grand Prize is a trip to Dover, DE to attend 2022 Firefly Music Festival ("Entry Period 1 Firefly Festival Grand Prize"). Each Entry Period 1 Firefly Festival Grand Prize includes round-trip coach class air transportation from a major commercial airport near winner's residence to Dover, DE for winner and one (1) adult guest, four (4) nights hotel standard accommodations (single room/double occupancy), two (2) general admission tickets to the 2022 Firefly Music Festival, \$600 for winner only. Winner's guests must be 21 years of age or older. If the winner elects to travel or partake in the Prize without a guest, no additional compensation will be awarded to the winner. Winner and guest must travel on September 22, 2022 and return on September 26, 2022 or prize will be forfeited. Winner and guests must travel on the same itinerary. The ARV of each Entry Period 1 Firefly Festival Grand Prize is \$4,460.
- iii. **Entry Period 2 Grand Prize (2):** Each Entry Period 2 Grand Prize is a trip for two (2) to Orlando, Florida to attend the Electric Daisy Carnival Orlando. Trips include round-trip coach class air transportation from a major commercial airport near winner's residence to Orlando, FL for winner and one (1) adult guests, four (4) nights hotel standard accommodations (single room/double occupancy), two (2) tickets for 3-day admission to the Electric Daisy Carnival Orlando at Tinker Field in Orlando, FL scheduled to take place on November 11, 2022 – November 13, 2022, \$600 for winner only. Winner's guest must be twenty-one (21) years of age or older. Winner and guests and must abide by all festival and venue policies. Festival Entities reserve the right to revoke full or partial prize from any winner or winner's guest who it and/or festival/venue personnel deem may, in their sole discretion, be intoxicated, be a safety risk, have violated any festival/venue policy or law, and/or may bring Sponsor or Festival Entities into disrepute. Sponsor and Festival Entities have no responsibility for lost, stolen, misplaced or mutilated tickets, or any other occurrences beyond their control. No refund or compensation will be made in the event of the cancellation or delay. Sponsor and Festival Entities have no responsibility for a winner's inability or failure to accept or use any part of the prize as described herein. By claiming tickets, you agree to Front Gate Tickets' [Terms of Use](#), and to abide by the health and safety measures in effect at the time of your event, which may include, but not be limited to, wearing masks, providing proof of vaccination status and/or providing proof of negative COVID-19 status. If the winner elects to travel or partake in the Entry Period 2 Grand Prize without a guest, no additional compensation will be awarded to the winner. Winner and guest must travel on

November 10, 2022 and return on November 14, 2022 or prize will be forfeited. Winner and guests must travel on the same itinerary. The ARV of each Entry Period 2 Grand Prize is \$4,120.

For All Trip Prizes: The actual value of the trip may vary depending on point of departure and fluctuations in the cost of air transportation. Any difference between the estimated ARV and the actual value of the prize will not be awarded. If winner resides within a 100-mile radius of destination, ground transportation may be provided in lieu of air transportation, and no compensation will be provided for any difference in prize value. Travel dates are subject to availability; blackout dates and other restrictions may apply. Winner and guest are responsible for having valid travel documents including government identification and/or passports. No more than four (4) Entry Period 1 Grand Prizes and two (2) Entry Period 2 Grand Prizes will be available in the Sweepstakes.

- B. First Prizes (10 total; 5 per Entry Period):** Each first prize is a festival merchandise kit that includes a cooler, Instant Film Camera, Water Bottle, Baseball Cap and Fanny Pack (each a "First Prize"). No more than ten (10) First Prizes will be available in the Sweepstakes, five (5) per Entry Period. The ARV of each First Prize is \$250.
- C. Second Prizes (10 total; 5 per Entry Period):** Each second prize is SKYY branded Water Bottle, Baseball Cap and Fanny Pack (each a "Second Prize"). No more than ten (10) Second Prizes will be available in the Sweepstakes, five (5) per Entry Period. The ARV of each Second Prize is \$100.
- D. Total ARV:** The total ARV of the prize is \$28,100.

E. Odds of Winning: The odds of winning a prize depend on the number of eligible Sweepstakes entries received during each Entry Period.

F. General Conditions: There is a limit of one (1) prize per person. In no event will more than four (4) Entry Period 1 Grand Prizes, two (2) Entry Period 2 Grand Prizes, ten (10) First Prizes (five [5] per Entry Period, and ten (10) Second Prizes (five [5] per Entry Period, be awarded. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes through a random drawing from among all eligible prize claims received.

6. HOW TO CLAIM A PRIZE: The potential winners are subject to verification of eligibility and compliance with these Official Rules. After the random drawing, Administrator will notify the potential winners via e-mail at the e-mail address provided at the time of registration. Each potential Grand Prize winner will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within five (5) calendar days from the date of attempted notification or the prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor's sole and absolute discretion. Failure to provide all required information and a signature on the documents within the stated time period may result in forfeiture of a winner's right to claim his/her prize, and may result in the prize being awarded to an alternate winner, if time permits. If a potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, declines to accept a prize, the respective prize may be forfeited. If a prize is forfeited, the prize may be awarded to an alternate Winner, selected in a random drawing from among all remaining eligible entries, as determined by Sponsor in its sole discretion. If, after a good-faith attempt, Sponsor is unable to award or deliver a prize, the prize may not be re-awarded. Upon verification of eligibility, the Grand Prize winners will be contacted to make arrangements for the Grand Prize and each First Prize and Second Prize will be mailed to the winners at the physical addresses (P.O. Boxes are not permitted) provided at the time of entry. Any portion of a prize not accepted by winner will be forfeited. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for his/her prize won. Sponsor will issue an IRS Form 1099-MISC for each Grand Prize winner. All other costs and expenses not expressly set forth herein shall be solely each winner's responsibility. The prizes will only be awarded to verified winners.

Sponsor will attempt to notify each potential winner as set forth above, but Sponsor is not responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a winner's privacy or spam filter settings which may divert any Sweepstakes e-mail, including any winner notification e-mail, to a spam or junk folder. Prizes that are unclaimed, unredeemed, or returned as undeliverable will not be awarded.
